I, Lilian Hacherelle, of the City of Bradentown, County of Manatee and State of Florida, do hereby make, publish and declare this to be my Last Will and Testament, hereby revoking any and all other will or wills and codicil or codicils to will or wills by me heretofore made.

VII.

I give, devise and bequeath to the Old People's Home of Tampa, Florida, its successors and assigns, the sum of One Thousand (\$1,000) Dollars.

VIII.

I give, devise and bequeath to the Masonic Lodge at Bradentown, Florida, the sum of Five Hundred (\$500) Dollars.

IX.

I give, devise and bequeath to the Womans' Club of Bradentown, Florida, its successors and assigns, the sum of Five Hundred (\$500) Dollars.

X.

I give, devise and bequeath to the Orphans' Home of Tampa, Florida, its successors and assigns, the sum of One Thousand (\$1,000) Dollars.

XI.

All of my bedding, cut glass, linens, clothing, furniture, pictures and all other household effects, I give, devise and bequeath to Mrs. James Pettigrew of Palma Sola, Florida, her heirs and assigns.

XII.

To Mrs. John T. Campbell of Bradentown, Florida, her heirs and assigns, I give, devise and bequeath my Clock, Candelabra and Bronzes.

XIII.

To Mrs. John B. Leffingwell of Bradentown, Florida, her heirs and assigns, I give, devise and bequeath my Marble Bust of Sapho.

XIV.

All of my jewelry, I give, devise and bequeath to the wife of my brother, Arthur DeRocher of Berlamont, Michigan.

XV.

My mahogany sewing table and mahogany drop leaf table, I give, devise and bequeath to Mrs. Harry Horney of Bradentown, Florida.

XVI.

I direct that all of my bric-a-brac shall be sold and form a part of the residum of my Estate, and I hereby make the Methodist Orphanage at Enterprise, Florida, the residuary legatee under this Will.
